ATTIRE - Swimsuits - Girls can wear a one or two piece, Flip flops or sandals required for all contestants.

PHOTOGENIC - (optional) - Submit an 8x10 color or black & white photo at registration (do not mail photos). Please label child's name and age division on the back of the photo. Photos are judged on personality, quality and naturalness. Winners will receive a Medallion or a gift (director's choice).

SIDE AWARDS - (optional) - *Best Smile, Best Personality & Most Beautiful/Handsome* - These are judged during the collective line up. Winners will receive Medallions or a gift (director's choice).
